On September 7, 2022, about 0045 hours, Dublin Police Services (DPS) responded to 3112 Colebrook Lane in Dublin, CA, for a report of shots fired.

The reporting party called 911, and someone they did not know was inside their residence. One of the residents picked up the phone and advised the suspect was armed with a firearm, and the suspect shot his sister and his brother-in-law. The reporting party advised the suspect left the scene in a vehicle.

DPS Units responded to the scene and located the two victims, a husband and wife, who had gunshot wounds to their heads and neck. Alameda County Fire personnel arrived and pronounced the victims deceased. Multiple family members who witnessed the shooting were present during the shooting. When deputies arrived, they heard an unknown family member say, "Devin" and "He is a cop."

Detectives reviewed license plate readers, which revealed a grey-colored Volkswagen Sedan (CA: 6MEA916) driving south on Fallon Gateway in the City of Dublin, CA, at 0046 hours, 1 minute after the shooting. Fallon Road is the closest main thoroughfare to Interstate 580 from the crime scene. A registration check of the Volkswagen revealed it was registered to a Devin Williams out of Stockton. Devin Williams with a Date of Birth of 7/26/1998 was a deputy with the Alameda County Sheriff's Office.

Detectives responded to the scene and located shell casings with "Speer 9mm" inscribed on them. The Alameda County Sheriff's Office uses Speer 9mm ammunition. Detectives listened to the 911 call and believed (6) gunshots on the audio tape. Detectives later recovered (6) firearm shell casings at the scene of the crime. Witnesses told Sheriff's Radio the suspect fled the scene.

Detectives created a sequential photographic lineup, and two separate witnesses identified Devin Williams as the suspect who shot the two victims. Devin Williams was also known to the witnesses.

Detectives authored a Ramey Warrant (WAR764796) for Williams for PC 187 - Murder which an Alameda County Judge granted. At about 1107 hours, Devin Williams called DPS and peacefully surrendered to CHP Coalinga in Fresno County, CA, about 147 miles from the crime scene in his Volkswagen with California license 6MEA916.

Williams issued duty weapon box, and some of his safety gear, including Speer ammunition, was inside his car. Red matter believed to be blood was also inside the vehicle.

Detectives spoke with Devin's father, who advised he was aware that Devin had been in a dating relationship with the female victim and had been to their residence in Stockton, CA.

Williams invoked his Miranda Rights and was booked into Santa Rita Jail.
